UNAUDITED SALES VOLUME IN NOVEMBER 2016

The board of directors of Geely Automobile Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the total sales volume of the Group for the month of November 2016 reached another record high at 102,422 units, an increase of approximately 99% over the same period last year and up approximately 7% from October 2016. The Group’s exports volume was 1,721 units in November 2016, up around 102% from the same period last year. During the month of November 2016, the Group’s total sales volume in China market was 100,701 units, an increase of around 99% from the same period last year, and exceeding the strategic level of 100,000 units for the first time ever in its history. The total sales volume in the first eleven months of 2016 was 657,621 units, up about 44% from the same period last year and achieving 94% of the revised full year sales volume target of 700,000 units in 2016.

During the month of November 2016, the sales volume of “New Emgrand” was 28,842 units, an increase of about 33% from the same period last year. The sales volume of “Vision” sedan was 14,404 units in the month of November 2016, up about 5% year-on-year. The Group’s “Geely GC9” (吉利博瑞), its B-segment sedan model, achieved a sales volume of 5,172 units in the month of November 2016. The sales volumes of all the Group’s new models launched in 2016 achieved record levels in November 2016. The “Geely Boyue” (吉利博越), its newest SUV model, recorded a sales volume of 18,402 units in the month of November 2016. The “Emgrand GS” (帝豪GS), its first crossover SUV model, recorded a sales volume of 10,078 units in the month of November 2016. The “Vision SUV” (遠景SUV), its new SUV model, recorded a sales volume of 10,942 units in the month of November 2016. The “Emgrand GL” (帝豪GL), its new generation of A+ segment sedan model, recorded a sales volume of 10,010 units in the month of November 2016.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company's auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
