VOLUNTARY ANNOUNCEMENT
SALES VOLUME IN APRIL 2010

This is a voluntary announcement made by Geely Automobile Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the total sales volume of the Group for the month of April 2010 was 32,441 units of vehicles, an increase of 24.7% over the same period last year and up approximately 7.2% from March 2010. The total sales volume in the first four months of 2010 was 135,279 units of vehicles, up 55.1% from the same period last year and achieving 33.8% of the full year sales volume target of 400,000 units of vehicles in 2010.

During the month of April 2010, the sales volume for “Free Cruiser”, “Geely Kingkong” and “Vision”, the Group’s three best selling models, were 5,588 units of vehicles, 7,141 units of vehicles and 4,233 units of vehicles, respectively. Also, the sales volume for “Emgrand” was 5,414 units of vehicles during April 2010, up 25% from the previous month.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company’s auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
