**VOLUNTARY ANNOUNCEMENT
SALES VOLUME IN APRIL 2013**

This is a voluntary announcement made by Geely Automobile Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the total sales volume of the Group for the month of April 2013 was 44,491 units, an increase of approximately 22% over the same period last year, but was down approximately 7% from March 2013. The total sales volume in the first four months of 2013 was 187,377 units, up 21% from the same period last year and achieving 33% of the full year sales volume target of 560,000 units in 2013.

During the month of April 2013, the Group’s sales volumes under “Emgrand”, “Englon” and “GLEagle” brands were 14,391 units, 13,990 units and 16,110 units, respectively. The aggregate sales volume of GX7 and SX7, the Group’s Sport Utility Vehicles (SUVs), was 4,590 units in April 2013.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company’s auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
