**VOLUNTARY ANNOUNCEMENT
SALES VOLUME IN NOVEMBER 2013**

This is a voluntary announcement made by Geely Automobile Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the total sales volume of the Group for the month of November 2013 was 57,107 units, an increase of approximately 11% over the same period last year and up approximately 2% from October 2013. The total sales volume in the first eleven months of 2013 was 488,702 units, up 15% from the same period last year and achieving 87% of the full year sales volume target of 560,000 units in 2013. The Group’s exports volume was 12,128 units in November 2013, up around 51% from the same period last year. During the month of November 2013, the Group’s total sales volume in China market was 44,979 units, an increase of around 4% from the same period last year.

During the month of November 2013, the sales volume of the Group’s best selling model “Emgrand EC7” attained its record high at 20,954 units, an increase of about 27% over the same period last year. The aggregate sales volume of “GX7” and “SX7”, the Group’s Sport Utility Vehicles (SUVs) reached 6,335 units in November 2013, an increase of about 36% over the same period last year. Also, the sales volume of “GC7” was 6,116 units in November 2013, again a record high for the model, and a significant increase of around 169% over the same period last year.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company’s auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
