**VOLUNTARY ANNOUNCEMENT
SALES VOLUME IN DECEMBER 2009**

This is a voluntary announcement made by Geely Automobile Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the total sales volume of the Group for the month of December 2009 was 43,446 units of vehicles, an increase of approximately 108% over the same period last year and an increase of approximately 23% from November 2009. The monthly sales volume in December 2009 was the best level achieved by the Group in its history. For the full year of 2009, the total sales volume of the Group was 325,413 units of vehicles, an increase of approximately 59% over the year ended 31 December 2008, and exceeding the Group’s total sales target of 250,000 units of vehicles for the year 2009.

During the month of December 2009, the sales volume for “Free Cruiser”, “Geely Kingkong” and “Vision” were 13,284 units of vehicles, 10,961 units of vehicles and 5,546 units of vehicles, respectively.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company’s auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
