If this form is duly signed and returned but without specific direction given on any of the proposed resolutions, your proxy may vote or abstain at his/her discretion in respect of all resolutions. Your proxy will also be entitled to vote at his/her discretion on any resolutions properly put to the Annual General Meeting other than those referred to in the notice convening the meeting.
- e. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be either under its common seal or under the hand of an officer, attorney or other person duly authorised to sign the same.
- f. In order to be valid, this form of proxy together with the power of attorney (if any) or other authority (if any) under which it is signed, or a notarially certified copy of such power of authority, must be deposited at the office of the Company's Hong Kong share registrar and transfer office, Union Registrars Limited, at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong not less than 48 hours before the time appointed for holding of the Annual General Meeting.
- g. In the case of a joint registered holders of any Shares, this form of proxy may be signed by any joint holder. Any one of such joint registered holders may vote at the Annual General Meeting, either personally or by proxy, in respect of such Shares as if he/she was solely entitled thereto; but if more than one of such joint registered holders be present at the meeting, either personally or by proxy, that one of the joint holder so present whose name stands first on the register of members of the Company in respect of the relevant joint holding shall alone be entitled to vote in respect thereof to the exclusion of the votes of the other joint holders.
- h. Completion and return of this form will not preclude you from attending and voting at the Annual General Meeting if you so wish. If you attend and vote at the meeting, the authority of your proxy will be revoked.
