Geely Automobile Holdings Limited TOTAL SALES VOLUME FOR MARCH 2024 WAS 150,835 UNITS TOTAL SALES VOLUME UP 39% YOY

(HONG KONG, 1 April, 2024) --- Geely Automobile Holdings Limited ('Geely Automobile'/the 'Group') (Stock codes: 175 (HKD counter) and 80175 (RMB counter)) announced that the total sales volume of the Group during the month of March 2024 was 150,835 units of vehicles, an increase of approximately 39% from the same period last year. Save as the sales volume disclosed above, during the month of March 2024, Proton** achieved sales volume of 13,770 units of vehicles, representing a decrease of approximately 6% compared to the same period last year. Further, in the first three months of 2024, the cumulative sales volume of Proton reached 42,905 units of vehicles, representing an increase of approximately 1% compared to the same period last year.
