### UNAUDITED SALES VOLUME IN JUNE 2026

The board of directors of Geely Automobile Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the Group’s total sales volume for June 2026 was 240,799 units of vehicles, representing an increase of approximately 2% compared to the same period last year. Save for the sales volume disclosed above, Proton achieved a sales volume of 16,313 units of vehicles in June 2026, representing an increase of approximately 42% compared to the same period last year. Further, in the first half of 2026, the cumulative sales volume of Proton reached 95,167 units of vehicles, representing an increase of approximately 23% compared to the same period last year.
