UNAUDITED SALES VOLUME IN AUGUST 2026

The board of directors of Geely Automobile Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the Group’s total sales volume for August 2026 was 270,194 units of vehicles, representing an increase of approximately 8% compared to the same period last year. Save for the sales volume disclosed above, Proton achieved a sales volume of 22,426 units of vehicles in August 2026, representing an increase of approximately 47% compared to the same period last year. Further, in the first eight months of 2026, the cumulative sales volume of Proton reached 137,192 units of vehicles, representing an increase of approximately 29% compared to the same period last year.

Please note that the figures disclosed in this announcement are unaudited, have not been confirmed by the Company's auditor, and may be subject to adjustment and final confirmation.
